

BEING A BY-LAW OF THE SUMMER VILLAGE OF ISLAND LAKE SOUTH IN THE PROVINCE OF ALBERTA TO AUTHORIZE THE ADOPTION OF A CREST.

WHEREAS, Section 147(1) of the Municipal Government Act empowers a Council, with the approval of the Minister to adopt a Crest or Coat of Arms; and

WHEREAS, the Council of the Summer Village of Island Lake South considers it desirable to adopt an official Crest for the Village.

NOW THEREFORE, the Council of the Summer Village of Island Lake South duly assembled enacts as follows:

- (1) That the Crest as set out in Schedule "A" attached hereto and forming part of this by-law is hereby adopted by the Summer Village of Island Lake South, subject to approval of the Minister.
- (2) The adoption of the Crest is effective upon the date of the final passing of this by-law.

READ a first time this 26th day of July, 1984.

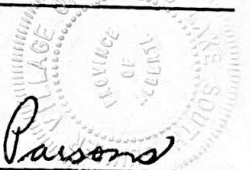
READ a second time this 26th day of July, 1984.



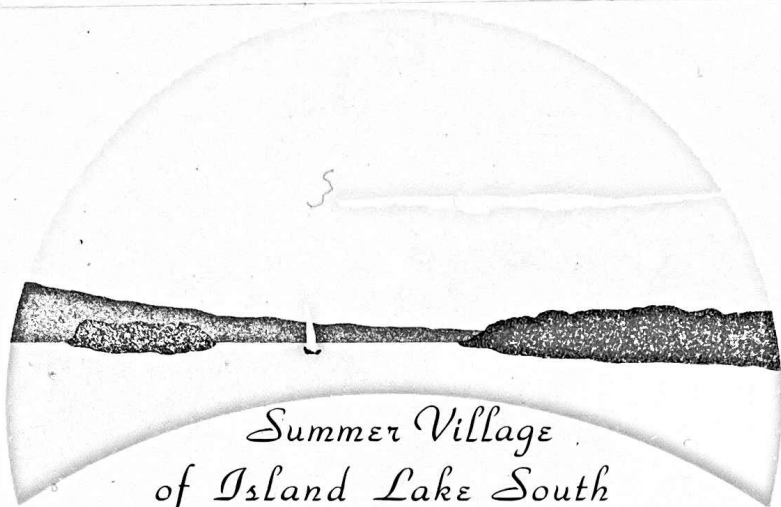


