BY-LAW NO. 29/89

BEING A BY-LAW OF THE SUMMER VILLAGE OF ISLAND LAKE SOUTH TO AUTHORIZE THE MAKING OF AN AGREEMENT WITH THE COUNCILS OF THE FOLLOWING:

FOR THE JOINT CONTROL, OPERATION, MANAGEMENT AND USE OF AMBULANCE SERVICE.

WHEREAS the Councils of the County of Athabasca No. 12, the Town of Athabasca, Improvement District No. 17, Summer Village of Sunset Beach, Summer Village of South Baptiste, Summer Village of West Baptiste, Summer Village of White Gull, Summer Village of Whispering Hills, Summer Village of Island Lake, Summer Village of Island Lake South (hereinafter collectively referred to as "the municipalities") consider it a benefit to their respective Municipalities which is included within the present boundaries of the Athabasca General Hospital District No. 13 (Hereinafter referred to as "the Ambulance Service Area"; and

WHEREAS the Municipalities wish to enter into an Agreement with each other for the joint arrangement and provision of ambulance service within the Ambulance Service Area and for the control, operation, Management, and use of ambulance service with the Ambulance Service Area.

WHEREAS Section 113 of the Municipal Government Act being Chapter M-26 RSA 1980, authorizes the Council of the Summer Village of Island Lake South to enter into agreements for the provision of various services,

NOW THEREFORE, THE COUNCIL OF THE SUMMER VILLAGE OF ISLAND LAKE SOUTH, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED ENACTS AS FOLLOWS:

- 1. That the Summer Village of Island Lake South shall forwith enter into an Agreement with the County of Athabasca No. 12, the Town of Athabasca, Improvement District No. 17, Summer Village of Sunset Beach, Summer Village of South Baptiste, Summer Village of White Gull, Summer Village of Whispering Hills, Summer Village of Whispering Hills, Summer Village of Island Lake for the joint arrangement and provision of ambulance service within the Ambulance Service Area and for the joint control, operation, management and use of ambulance service within the Ambulance Service Area, such Agreement to be in the form of the Agreement attached to this By-Law as Schedule "A", and that the Mayor and Municipal Administrator are hereby authorized and instructed to execute the said Agreement under the corporate seal of the Summer Village of Island Lake South.
- 2. That two (2) members of Council or alternates, appointed by resolution of Council shall be members for the Summer Village of Island Lake South of a joint committee together with the members of the said other Municipalities, which committee shall be designated and known as "The Athabasca & District Ambulance Authority".

- 3. That the authority to arrange for and provide ambulance service for the Ambulance Service Area and authority to control, operate, manage and use ambulance service within the Ambulance Service Area is hereby declared to The Athabasca & District Ambulance Authority in accordance with the provisions and subject to the limitations contained in the Agreement attached as Schedule "A" to this By-Law.
- 4. That this By-Law shall come into force and effect upon the date of its final reading.

SCHEDULE "A"

TO BY-LAW NUMBER 29/89

- 1. That the Authority obtain ownership of the assets of the Athabasca Ambulance Society.
- 2. That the Authority negotiate with a private ambulance company to provide ambulance service to The Ambulance Service Area for a period of one (1) year (January 1, 1989 to December 31, 1989) and that the Authority be authorized to use a portion of its equity to have this service provided at a "no cost basis" for that period.
- 3. That the Authority use this time to consider the standards of service, to analyze its financial position, and to project anticipated future costs and to do all other necessary things to fully investigate the ambulance operation and, thereafter, to submit these recommendations to the members of the Authority for final ratification.
