## SUMMER VILLAGE OF ISLAND LAKE SOUTH

## IN THE PROVINCE OF ALBERTA

BY-LAW #60/98

BEING A BY-LAW OF THE SUMMER VILLAGE OF ISLAND LAKE SOUTH, IN THE PROVINCE OF ALBERTA, TO ENTER INTO AN AGREEMENT TO ESTABLISH AN EFFICIENT AND ENVIRONMENTALLY ACCEPTABLE WASTE MANAGEMENT SYSTEM FOR THE BENEFIT OF ALL PARTICIPATING MUNICIPALITIES WITH:

County of Athabasca #12
Town of Athabasca
M.D. of Lesser Slave River #124
Summer Village of Island Lake
Summer Village of Island Lake South
Summer Village of Whispering Hills
Summer Village of West Baptiste
Summer Village of South Baptiste
Summer Village of White Gull
Summer Village of Sunset Beach

WHEREAS, under the provisions of the Municipal Government Act, S.A. 1994 Chapter M-26.1 and amendments thereto, a municipality may enter into an agreement with other municipalities for a common purpose; and

WHEREAS, the Council of the Summer Village of Island Lake South, has deemed it expedient and in its best interest to enter into such an agreement.

NOW THEREFORE, the Council of the Summer Village of Island Lake South duly assembled enacts as follows:

 That the Summer Village of Island Lake South enter into an agreement with the Municipalities of:

County of Athabasca #12
Town of Athabasca
M.D. of Lesser Slave River #124
Summer Village of Island Lake
Summer Village of Whispering Hills
Summer Village of West Baptiste
Summer Village of South Baptiste
Summer Village of White Gull
Summer Village of Sunset Beach

for the purpose of construction, maintaining, controlling and managing a regional waste management system.

- 2. That a Committee comprised of two (2) representatives of the Council of the Town of Athabasca, two (2) representatives of the Council of the County of Athabasca #12, two (2) representatives of the Council of the M.D. of Lesser Slave River #124, and one (1) representative of each of the Summer Villages of Island Lake, Island Lake South, Whispering Hills, West Baptiste, South Baptiste, White Gull and Sunset Beach be formed and that this Committee be known as the "Athabasca Regional Waste Management & Recycling Authority".
- 3. That voting right on the Athabasca Regional Waste Management Authority shall be:

Town of Athabasca - Four (4) votes
County of Athabasca - Four (4) votes
M.D. of Lesser Slave River - Four (4) votes
Summer Villages - One (1) vote each

- 4. That the Town of Athabasca act as sole banking agent and administrative centre with a Town of Athabasca representative to be chairman, and in the absence of a Town of Athabasca representative a County of Athabasca representative shall assume the chair, and the Municipal Manager of the Town of Athabasca to be Secretary-Treasurer.
- 5. That all funds for operation of the Committee be handled by the Town of Athabasca and that separate accounting records be kept for this purpose.
- 6. That the Committee be authorized to disburse funds for the purpose of the Athabasca Regional Waste Management Facility within the guidelines as established by the participating municipalities and to requisition on the formula as set out in Schedule "A" attached.
- That an audited financial statement be provided to each municipality upon completion of the project.
- 8. That By-Law #32/90 of the Summer Village of Island Lake South is hereby repealed.
